

ISTYLE GIFT VOUCHER PROMOTION POLICY

1. The organizer of the promotion

1.1 The organizer of the promotion is the Semmelweis Premium Ltd (Seated: 1085 Budapest, Üllői út 26., company registration number: 01-09-879749, tax number: 13916974-4-42, group identification/tax number: 17784234-5-44), hereinafter referred to as: Organizer.

1.2 Within the framework of the promotion, the Organizer's cooperating partner is iSTYLE Hungary Kft. (Seated: 1033 Budapest, Ángel Sanz Briz út 13. building D., company registration number: 01-09-861222, tax number: 13552813-2-44), hereinafter referred to as: iStyle.

1.3 The name of the promotion is „Simmelweis ring + iStyle gift voucher” promotion.

1.4 The point of the promotion is that every natural person who purchases a Semmelweis ring from Organizer during the promotion period will receive an iStyle gift voucher with a nominal value of HUF 50,000 (i.e. fifty thousand Hungarian forints) from Organizer after the purchase.

2. Duration of the promotion

2.1 Promotion starts on 10 June 2026 and lasts until 30 June 2026. During the promotion Organizer reserves the right to suspend or terminate the promotion at any time, notifying participants on its website.

2.2 Organizer reserves the right to change the start or end date of the promotion; participants will be informed of the change in an appropriate manner.

3. Terms of participation

3.1 The promotion is open to all natural people over the age of 18 who purchase a Semmelweis ring from Organizer during the promotion period.

3.2 An additional condition for participating in the promotion is that the participant accepts these rules and provides the necessary information for the purchase (name, contact information).

3.3 Employees of Organizer and their immediate families may participate in the promotion if they meet the conditions mentioned above.

4. Gift voucher features

4.1 The gift is a digital iStyle gift voucher with a nominal value of HUF 50,000. The voucher will be delivered to the e-mail address provided by the buyer. After sending the voucher, Organizer does not take any responsibility for delivery problems resulting from the operation of e-mail service providers, their filtering systems or other technical circumstances, especially if the electronic message ends up in the spam, promotions or other filtered folder. Organizer also does not take any responsibility for any damage or disadvantages resulting from the unauthorized use, hacking, inaccessibility of the buyer's e-mail account, incorrect entry of the e-mail address, or any circumstances arising in the buyer's sphere of interest and as a result of which the voucher is not received, lost, deleted or falls into the possession of an unauthorized person. Organizer's records and electronic systems data are used to verify the successful delivery of the voucher.

4.2 The gift voucher is issued electronically by iStyle and contains a coupon code, QR code and barcode.

4.3 The gift voucher can be used in the Hungarian web shop of iStyle Hungary Kft. (istyle.hu) to purchase any product available in the web shop. The voucher cannot be used to purchase services or service-type products available in iStyle stores.

4.4 The validity period of the gift voucher is 180 days from the date of issue. After the expiration date, the certificate cannot be used and the balance on it will be lost.

4.5 The gift voucher balance can be used in several instalments; the current balance is recorded in the iStyle system. During use, the total purchase amount is deducted from the value of the voucher; if the purchase amount exceeds the voucher balance, the buyer is obliged to pay the difference.

4.6 The gift voucher cannot be exchanged to cash, is non-refundable, and cannot be replaced if it has been lost or destroyed.

4.7 The voucher can also be used to purchase products on sale or at a discounted price, and there is no minimum purchase value limit.

5. Receiving the gift voucher

5.1 The participant will receive the gift voucher from Organizer after purchasing the Semmelweis ring. The gift voucher is valid for 180 days from the date of issue by iStyle. The participant acknowledges and accepts that the gift voucher will be received within 3 working days from the date of issue for administrative reasons. The voucher is a digital file with a unique identifier.

5.2 The participant is obliged to preserve the voucher intact and ensure that the voucher data (coupon code, QR code, barcode) is not disclosed to third parties.

6. Using the gift voucher

6.1 The voucher can be used in the istyle.hu web store. To use it, the customer must enter the coupon code or QR code on the cart page of the web store.

6.2 The simultaneous use of multiple vouchers during a purchase is carried out in accordance with iStyle's current general voucher use policy.

6.3 The voucher cannot be used in person at iStyle stores in Hungary.

6.4 When using the gift voucher, the current voucher use policy of iStyle Hungary Kft. applies. The regulations are available on the istyle.hu website.

7. Data management

7.1 When participating in the promotion, participants provide Organizer their personal data (e.g. name, contact information) necessary for the purchase. The Organizer processes the personal data solely for the purpose of conducting the promotion, delivering the gift vouchers and maintaining contact.

7.2 Organizer processes personal data in accordance with the applicable data protection laws. iStyle does not receive any personal data of customers in connection with the transfer of vouchers, therefore the Parties are not considered to be each other's miscellaneous regulations data processors.

8. Miscellaneous regulations

8.1 Organizer reserves the right to amend these rules or terminate the promotion at any time. The amendments will be published on the Organizer's website and will enter into force on the day of publication.

8.2 Organizer is not responsible for any damages resulting from incorrect use, loss or destruction of the voucher.

8.3 In matters not regulated in these regulations, the Civil Code (Ptk.), iStyle's voucher usage regulations in force all times and its general terms and conditions shall apply.

8.4 By participating in the promotion, participants acknowledge that they have read and accept all the terms and conditions contained in these rules.
